DAVID VS. GOLIATH

JUSTICE WITHOUT AN ATTORNEY?

NOVEMBER 30, 2017 - 9:00 AM TO 1:00 PM, Los Angeles, California

A Peaceful [Silent] Protest will be at Los Angeles, California, near intersection of 255 East Temple St. & Judge John Aiso St.

Daniel Borsotti discovered corruption by firsthand experiences: State Judge Michael J. O’Gara blocked facts and misstated the law to the jury, despite objections by Borsotti.. Federal Judge Sheri A. Bluebond refused to let Borsotti enter the courthouse, and then ruled against him for nonappearance. Federal Judge Fernando Manzano Olguin, 14 times, with full knowledge, issued clearly unlawful orders, thus protecting the bank’s stealing of land. J.P. Morgan Chase Bank, Nationstar Mortgage, LLC (aka Mr. Cooper), & Quality Loan Service Corporation are very happy.

As was done in Russia, State Judge Michael J. O’Gara spitefully ordered Borsotti into a fruitless psychiatric examination, with the assistance of a compliant public defender. Bail set at \$100,000. Borsotti was not allowed to present substantive evidence or witnesses to the jury. He was sentenced to one year imprisonment without being heard. The crime? Borsotti was unable to completely roll down his broken car window.

Federal Judge Fernando Manzano Olguin unlawfully usurped the tribunal’s decision-making power. In a little known court rule, the judge is prohibited from making any decision. That power is reserved to the court’s tribunal. Five times Judge Olguin was fined for contempt of court. Corruption runs so deep that the Marshals of the court are afraid to enforce a contempt bench warrant for the arrest of the judge.

Federal Judge Sheri A. Bluebond, in open court, claimed it was “above my pay grade” to order the marshals to quit blocking Borsotti’s access to the court. Later, a marshal admitted that the judge ordered him to block Borsotti’s access to the building. Borsotti’s offense? He quietly requested recognition of Constitutional rights. In following proceedings the judge admitted all evidence from defendants, and denied all claimant’s evidence.

Complaints to judicial ethics agencies have to-date been invisible. They see no wrong. Borsotti says, “No wonder that *Transparency International* found that the USA was one of the world’s worst corrupt countries in 2006.”

Family Farm Foreclosure Assistance Project (FFFLAP) polled 641 people who had been in court facing one of the following: Government, lending institutions, or large corporations. The poll showed that:

98% of those *without* an attorney lost their cases.

97% of those *with* an attorney lost their cases.

"...we can only conclude that judges and the 'Officers of the Court' (the lawyers) are the protectors of corrupt government officials, institutions and large corporations."
