## HOW I FOUND OUT THE COURTS DO NOT OPERATE AS ADVERTISED by Daniel Borsotti

I.

Despite what you see on TV, hear on Radio or have experienced firsthand, the judges are not neutral. Their real job is to protect government and corporate special interest.

In September 2015 (Los Angeles Superior Court Cases E58887 & 5SR01622) I was sentenced to a year in jail because my car window could not be rolled all the way down. Incredible? Here's what happened.

In January, 2015 at the end of a freeway off ramp the CHP motorcycle officer made it clear that he wanted me to pull over and stop.

It was a high traffic area, so, in consideration of safety, I turned right, then prepared to turn left into a safe restaurant parking lot. Just before beginning the left turn the officer struck the car hard enough to break the SUV left rear corner panel. At the same time, he screamed multiple obscenities.

When I came to a full stop in the parking lot, the officer ordered me to roll down the window or else I would spend two days in jail. When the window could only be rolled down part way, he demanded that I get out of the SUV. Because of his frightening uncontrolled behavior, his repeated threats to take me to jail, and his claim that other officers were coming to take me to jail, I chose to wait in the SUV until they arrived.

When the officers arrived, one of them yelled, "You're under arrest! Get out of the car!" I said OK, started to get out of the car. As I did so, they grabbed, threw me about, wrenched my back, and slammed my body against the car.

After being taken to jail, I was charged with failure to obey an officer's command [resisting arrest, PC 148(a)(1)].

In June, 2015 I filed a Federal claim (2:15-cv-04112) against 31 State defendants. During the trial in August 2015, the State prosecution vindictively added 3 more bogus charges (7 months after the original arrest). The State judge, Michael J. O'Gara gleefully went along with the prosecutorial abuse. His vindictive glee also showed during sentencing. He protected the Government's interests.

To make matter worst, the banks appear to be in bed with the judiciary administrators. Oh my, could that be Truth?

In 2008 I financed my land in good faith through WAMU Bank. The account went through various transfers from bank to bank. I discovered significant frauds in the processing. Repeated queries to the bank were ignored and the bank started foreclosure on the property.

There is a little known rule that says a court of record must have a judicial tribunal exercising functions independently of the person of the magistrate [i.e. a judge] designated generally to hold it." The problem here is that judges believe they can ignore any law that limits their authority in the court room.

When I filed my claims, in each case the judge willfully ignored the law, and directly, unlawfully usurped the powers of the tribunal and interfered with the progress of these case:

The most abusive Judge, Olguin, had 4 Complaints of Judicial Misconduct (See Complaint No. 17-90034) filed in the Ninth Circuit. The record shows at least a dozen unlawful interferences with court process.

Similar to judges, banks seem genetically disposed to commit loan fraud and land theft by misapplying or ignoring the law. That's what those cases are about. Defendants include J.P. Morgan Chase Bank, Nationstar Mortgage LLC, and Quality Loan Services Corporation.

The Judiciary proactively defends the major corporations. Judicial corruption runs so deep that my only recourse is to bring these issues to the public.
